



- Enclosed is a copy of DepEd Regional Memorandum No. 159, s. 2024 and Memorandum DM-OUOPS-2024-02-01300 dated March 6, 2024, signed by ATTY. REVSEE A. ESCOBEDO, Undersecretary for Operations, and FRANCIS CESAR B. BRINGAS, Assistant Secretary for Operations, entitled "GUIDELINES ON THE MANDATORY 30-DAY VACATION OF TEACHERS," which is self-explanatory.
- 2. Attention is invited to the 1st paragraph of the above mentioned Memorandum, which states:

"Xxx No voluntary of mandatory tasks or activities shall be assigned to teachers from June 1 to 30, 2024."

- 3. In this regard, please be reminded that all teaching personnel SHALL NOT be required to report to their respective schools. Mandatory physical or virtual participation in both DepEd and non-DepEd activities and/or events are likewise prohibited during the said dates.
